**CEMETERY INTERMENT SERVICE FEE**

The Cemetery's Interment Service Fee is for our basic services and overhead relating to the final disposition of the deceased, as well as the general care and operations of the cemetery.

The fee includes:

- Use of the Cemetery's professional, union and non-union staff, facilities and equipment, to respond to and complete the request for interment / entombment / or inurnment services, as well as maintaining the Cemetery.
- Verifying ownership and right of burial privileges and confirming the permanent interment location.
- Coordination between Cemetery administration and grounds with the funeral director and/or family members requesting and authorizing the burial service, securing and issuing necessary permits and authorizations for the service, preparation of the space for the burial, and restoration of that space following the service.

**INTERMENTS**

A concrete or other permanent outer burial container is required except in situations of religious necessity. The Committal Service includes the use of the mausoleum or chapel, in lieu of graveside set-up, if requested; opening and closing of the grave or lawn crypt, the use of a casket carrier as needed, four folding chairs, and artificial grass matting around the opening and over the mound of displaced earth. Escort available via Delaware entrance, Forest Lawn; or Camp Rd. entrance, Lakeside; or Clinton Rd. entrance, St. Matthew's; or Main St. entrance, Williamsville.

<b>ADULT, SINGLE DEPTH .....</b>	\$1,306*
<b>ADULT, MULTIPLE DEPTH</b> Where such interments are allowed, the complete service & recording fee for each interment other than the last and topmost.....	\$1,445*

<b>SOCIAL SERVICE</b>	The cemetery reserves the right to decline social service burials on Saturdays or Sundays if no other services are scheduled on that day. The cemetery requests, and may require, that Social Service burials be made before noon. In the event of overtime, the standard charges apply.....	\$1,111*
<b>INFANT / CHILD</b>	For outer cases up to 5 feet. For outer cases over 5 feet, the adult interment fee shall apply. Space may be purchased especially for infant interments in special sections at Forest Lawn and at Lakeside.....	\$391*
<b>CREMATED BODY</b>	The cremated body, in an urn or temporary container, must be placed in a suitable outer case, a vault of concrete, fiberglass, Marbelon or steel..... NOTE: Urn vaults are prohibited in Forest Lawn, Section 18, Lot 420	\$880*
<b>PRIVATE SCATTERING</b>	Scattering, placement of cremated remains in the earth of a private grave with or without a biodegradable container.....	\$880*
<b>COMMUNITY SCATTERING</b>	Scattering, placement of cremated remains in a common vault and the recording thereof in either Forest Lawn or Lakeside.....	\$231*

**DUAL INTERMENTS**

When one cremated body is interred or entombed with one full body at the same time, this fee will be charged per cremated body in addition to the full body fee:

<b>DUAL INURNMENT</b>	This fee also applies to <i>inurnment</i> of the second of two cremated bodies at the same time in the same location.....	\$265*
<b>DUAL INTERMENT</b>	This fee also applies to <i>interment</i> of the second of two cremated bodies at the same time in the same location.....	\$291*

**CHAPEL MEMORIAL SERVICE RENTAL SERVICES**

**FOREST LAWN:**

The chapel at Forest Lawn may be rented for a memorial service only for a half day or a full day, which may include a visitation or wake with or without the presence of the casketed or cremated body, subject to cemetery approval. It includes the services of an organist.

**ST. MATTHEW'S:**

The chapel at St. Matthew's may be rented for a memorial service **ONLY FROM 3:00 TO 6:00 P.M.**, which may include a visitation or wake with or without the presence of the casketed or cremated body, subject to cemetery approval. It does not include the services of an organist. The half-day fee applies (see below).

**LAKESIDE:**

There is no chapel available at Lakeside Cemetery for rental.

**CREMATION SERVICE**

All battery-powered medical implants must be removed before cremation. Only combustible caskets will be accepted. All cremations are accepted and performed pursuant to the rules and regulations covering cremations posted at the crematory. In addition, the cemetery's current NYS-mandated Cremation Authorization form must be signed and submitted before the cremation may take place. A temporary container for the cremated body is furnished by the cemetery at no extra charge.

**DISINTERMENTS / DISENTOMBMENTS / DISINURNMENTS**

1. The cemetery reserves the right to schedule disinterments / disentombments / disinurnments at its own convenience.
2. *The service fees charged by a vault company or a funeral director in moving the outer case from the current space to the future space are not included herein.*
3. The fees herein relate only to the cemetery's opening and closing of the current interment / entombment / inurnment space (and, where appropriate, the reinterment / reentombment / reinurnment space).
4. *The cemetery reserves the right to mandate the family engage the services of a funeral director for a disinterment / disentombment / disinurnment.*
5. Contact the cemetery office to secure the required authorization forms.
6. *There will be an additional charge in the following instances:*
  - a. Removal of existing lettering from a niche or crypt & prepare it for future lettering.
  - b. Removal of a memorial and/or foundation from a grave.
  - c. Removal of the outer container from the cemetery in the case of a disinterment (removal of casket from the ground) and reentombment (replacement of the casket into a crypt space).
7. An Ensuraseal will be required in the case of a disinterment (removal of casket from the ground) and reentombment (replacement of the casket into a crypt space), and the cemetery's current price will be charged to the customer.

**FOUNDATIONS FOR MEMORIALS**

Foundations for memorials must be constructed by the cemetery and conform to the cemetery's regulations. Orders for foundations for memorials made before need shall be accepted only with written authorization of the lot owner or his agent and with written authorization of one of the same parties allowing Forest Lawn, Lakeside or Williamsville Cemetery to remove and replace the memorial if necessary to make an interment, in which event, the then prevailing fee for such removal shall be charged.
